1. **DepEd, Schools Division of Sorsogon (Province)**, through the Division Bids and Awards Committee (GAA FY 2022 - OSEC-5-22-7851)³ intends to apply the sum of **Five Million Fifty-Three Thousand Three Hundred Five Pesos and Three Centavos (Php 5,053,305.03)** being the Approved Budget for the Contract (ABC) to payments under the contract. **Bids received in excess of the ABC of each school for every lot shall be automatically rejected at bid opening.**

2. The *DepEd Schools Division Sorsogon* now invites bids for **CONSTRUCTION OF NEW HANDWASHING FACILITIES FOR VARIOUS SCHOOLS UNDER CY 2022 BASIC EDUCATION FACILITIES FUND (BEFF)**.⁴ Completion of the Works required per school *is indicated on the table above*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *Office of the BAC Secretariat, DepEd, Schools Division of Sorsogon (Province), Balogo Sports Complex, Barangay Balogo, Sorsogon City* and inspect the Bidding Documents at the address given below from **9:00a.m. to 5:00pm (office hours)**.
5. A complete set of **Bidding Documents may be acquired by interested bidders on July 19, 2022 to August 8, 2022** from the address below and upon payment of a non-refundable fee for the Bidding Documents in the **amount of Php 5,000.00 per lot**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, **provided that bidders shall pay** the applicable fee for the Bidding Documents not later than the submission of their bids.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. **Late bids shall not be accepted.**

8. **DepEd SDO Sorsogon Province** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract **at any time prior to contract award** in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.


