**DIVISION CONTINUING PROFESSIONAL DEVELOPMENT ACCREDITATION
SYSTEM (CPDAS) LAUNCHING**

1. The Memorandum from the Office of the Undersecretary Atty. Nepomuceno A. Malaluan titled **Continuing Professional Development (CPD) Application Process for DepEd Central Office and DepEd Regional Offices to the Professional Development Commission** directs the Regional Office to initiate application as CPD Provider of the Professional Regulation Commission (PRC). This would mean that all Training Programs of DepEd Regional Office V and DepEd Service Providers (SDOs) shall be assessed and submitted by the Department of Education-Regional Office V thru its duly designated CPD Manager to ensure consistency to NEAP Standards and/or PRC-prescribed standards.
2. As of this date, the PRC no longer accepts training programs presented by Teachers and School Leaders upon renewal of PRC License unless the program is registered in the list of accredited programs of the commission. Hence, there is a pressing need for institutionalized collaboration and optimization of training programs that should be aligned with DepEd Priorities and Standards as set by the National Educators Academy of the Philippines and the PRC.
