1. DepEd, Schools Division of Sorsogon (Province), through the Division Bids and Awards Committee intends to apply the sum of Twenty Million Two Hundred Eighty Eight Thousand Seven Hundred Two Pesos and Fifty Centavos (Php 20, 288, 702.50) being the Approved Budget for the Contract (ABC) to payment under the contract. Bids received in excess of the ABC of each school for every lot shall be automatically rejected at bid opening.

- 2. The *DepEd Schools Division Sorsogon* now invites bids for CY 2024 CONSERVATION AND RESTORATION OF GABALDON BUILDING PROGRAM.³ Completion of the Works required per school *is indicated on the table above*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorship, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- A complete set of Bidding Documents may be acquired by interested bidders on September 3, 2024 to September 23, 2024 08:00 a.m to 05:00 p.m from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Twenty Five Thousand Pesos (Php 25,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, **provided that bidders shall pay** the applicable fee for the Bidding Documents not later than the submission of their bids.

 - Bid opening shall be on September 23, 2024 09:00 a.m. at HRD & QMS Center, DepEd SDO Sorsogon, Balogo Sports Complex, Barangay Balogo, Sorsogon City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Please take notice that the Bids and Awards Committee shall mandatorily require a Special Power of Attorney to representatives who shall join/attend the bid opening, to effectuate special and limited purpose(s) such as to bid, contract or negotiate for the purchase, or all other actions necessary to participate, in the best interest of the procuring entity. Late bids shall not be accepted.
- 8. **DepEd SDO Sorsogon Province** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
