The DepEd Schools Division Sorsogon Province, through the FY 2023 SUB-ARO RO-5-24-0555, SUB-ARO RO-5-23-2747 intends to apply the sum of Six Million Six Hundred Thirty Six Thousand Four Hundred Thirty-Two Pesos Only (Php6,636,432.00) being the ABC to payments under the contract for the PROCUREMENT OF HAULING SERVICES AND DOOR-TO-DOOR DELIVERY FOR THE SCHOOL FURNITURE UNDER CY 2021 BASIC EDUCATION FACILITIES FUND (BEFF), Project No. 24-04-002. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The DepEd Schools Division Sorsogon Province now invites bids for the above Procurement Project. Delivery of the Goods is required by Ten (10) days upon receipt of Notice to Proceed. Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. - Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
